For incorrectly ordered items, merchandise must be returned within thirty (30) calendar days in unopened, like-new, 100% saleable condition and in original manufacturer's packaging. Product that is returned will be inspected and a credit will be issued. Product returns may be subject to a 15% restocking and shipping charge. If returned merchandise is not in resaleable condition or is beyond the thirty (30) day return period, no credit will be issued and the merchandise will be returned to customer.
